FROM THE SELECTMEN....

- * We are currently assessing a 1966 1st Class Pumper currently on loan to us from the Town of Chelsea. Town meeting will vote on purchase for the Arrowsic Volunteer Fire Department.
- * On the recommendation of the Land Committee, the Selectmen have made a purchase and sale agreement to acquire 8 acres near the current Fire Department building for future Town use. Town meeting will vote on spending \$42,000.00 for this property.
- * Property taxes: The 8% raise in property taxes this year is due to \$45,000.00 raised by the Town Meeting for additional road work on Rte. 127. Because the State of Maine has the areas we were considering on their list of upcoming jobs, we will not be spending this money and hopefully can use it to offset taxes next year.
- * Emergency Services: Mary Hillery and Greg Guckenburg have been attending meetings intended to research maintaining emergency and ambulance services to the region after the proposed closing of the Bath Hospital.
- * Bath Hospital: Pat Harcourt was on the Midcoast Hospital Task Force this Fall with surrounding Town officials and Midcoast Hospital Board members. Though the negotiations failed, Bath is still researching options. We'll keep you informed.
- * The Selectmen have a new assessing program which we will be using in the future. Volunteers are needed to enter data.
- * Squirrel Point Lighthouse has been given by Federal legislation to a private group that promises as part of the legislation to maintain public access and to keep up the property. More information on the transfer will be forthcoming.

From the Codes Enforcement Officer

As spring approaches many people begin to plan for home improvements and other projects. Some of these may require a permit. When you start planning a project you should also find out what permits, if any, arae required and how long it may take to get them. Some jobs require a plumbing permit.

Arrowsic has ordinances for tree cutting and timber harvesting that need to be consider when clearing land. In the Shoreland (250 feet from high water or edge of wetland) tree cutting rules are stricter than in other areas. Filling, grading and other earth-moving activities, even conctructing a driveway, usually require a permit. Sometimes they require more, such as a Planning Board Permit or a public hearing. Permits should be posted on the property where it is visible from the road. If you have any questions, call Dave Foster at 443-2114. Remember to get the permit before you begin the project.

FOOD CO-OP ACTIVE IN TOWN

Naturally Better Food Co-op is open for new members interested in joining their "buying club" for food. The co-op orders once a month, eleven times a year (no December order). Orders are placed the second Tuesday of the month and the food is delivered on the third Thursday. The Co-op's focus is not only organic foods, but healthy foods in general. Members order flours, grains baby foods, beans, condiments, sweets, teas, personal care items, frozen foods. There is no strict minimum order size, but orders must meet certain criteria from the distributor. There are two guiding principles to joining the co-op: 1. If you order, you must work at breakdown; 2. The food must be picked up on the Thursday it comes in and must be paid for then.
