- Ask select board to ask the association
- Review ordinance to see if we have a penalty for littering

Update on Shed Expansion Project

- Not much update
- Katie and Nadine met with the Select board, who were very supportive. We will give them update when we get estimates
- According to Mike K. The town office wants to reclaim the circuit on the side of the little barn.
- ARSWC needs to communicate with the Properties Committee that we are aware of this and we need electricity. This should be part of the building plans.

Grant proposal

- Proposal is in purchases and we still don't know when it will be out. Paul doesn't expect that we will have very much time to submit, so the more we get done beforehand the better.
- Reminder to contractors that we would like an estimate by December 10th
- · Challenge will be the 25% in kind contribution from the town.
- · Form is in the shared folder.
- Include information from the town report of all materials that the town recycles.

Proposal to change to year-round trash and recycling pick up every two weeks.

- Saving \$3660 in transportation cost of once a week pick up. (19.5%)
- Reduced emissions in town. Reduced impact on roads.
- Eliminate the problem of putting recyclables out non-recycling weeks.

Need to have this confirmed before we get budget proposal from Rogers

Set up calendar January to May

Prescription bottles and caps being held in the hope that the recycling will restart, 2 carafes taken to Goodwill where they accepted them. Coffee maker that's in the shed will be tested with the remaining carafe.
